Eve

Unbeknownst to a majority of Christians, there are *two versions of the Genesis story* and both are in the King James Bible.

Genesis 1 starts with God creating the heavens and the earth, “and the earth was a canvas upon which he separated the light from the darkness, water from the land, day and night, water creatures from those living creatures on land.” God said, “Let us make man in our own image, in the image of God, male or female.” Then, God blessed the entire endeavor and said, “Be fruitful and multiply.” There is no mention of who was made first, a man or a woman, in Genesis 1; in fact, it sounds like humans of both genders were made simultaneously.

Rebekah

Some errant scholars say that Rebekah "interfered" with her husband's choice; far too little is made of her correct decision. Isaac made his decision based on his love of wild game; she made her decision according to God's design. I see nothing that proves Esau was worthy of his father's inheritance, double portion of his father Isaac's estate when he died (Deuteronomy 21:17).

Without a doubt, Rebekah altered the course of history and she did it on purpose. The animosity between the two brothers was always present from the day they were born; she is to be commended for ensuring the lineage of Jesus would continue unabated. We have to also remember that when the Bible says "foreign women" they mean those who follow the ways of the Canaanites, worshipping Molech, throwing their firstborn child into the fire. As we know from the

Is the man always chasing after foreign skirts or is he faithful? Would he ask his wife to pretend to be his sister to evade personal danger? Would he put his wife out in front as a human shield when he falls from grace, in front of the cameras to “stand by your man” even when he is wrong? Would he ask his wife to debase herself and pose nude? Would he say: “The woman made me do it” when caught in the act? Weak men do that. They refuse to face the music when they break God's law.

Secondly, I like the phrase, “the man is the head but the woman is the neck.” There are times when women need to redirect the affairs of men in the proper direction. We are neck movers. We are catalysts for change. We like to see the right person get the job and the right person succeed and the person who did not work or deserve the accolades, moved to the side to learn a bit more before being put in charge. It's not about seniority; it's about who is more qualified and makes better decisions, and this should be true in the workplace as well. I would urge you to fight DEI which is a new form of discrimination that would say Esau, due to his dark skin, deserves priority over his light-skinned, less hairy brother.

Puah and Shiprah

“The king said to the Hebrew midwives, whose names were Puah and Shiprah, “When you help the Hebrew women in childbirth and observe them on the delivery stool, if it is a boy, kill him; if it is a girl, let it live.” The midwives, however, feared God and did not do what the King of Egypt told them to do; they let the boys live. Then the King of Egypt summoned the midwives and asked them, “Why have you done this? Why have you let the boys live?” The midwives answered Pharaoh, “Hebrew women are not like Egyptian women; they are more vigorous and give birth before the midwives arrive.” So God was kind to the midwives and the people increased and became more numerous. And because the midwives feared God, he gave them families of their own” [Exodus 1:15-20].

Newborn Babies: Dissected for Research

Planned Parenthood and its allies harvest baby body parts to sell them for profit. Abortion procedures were altered to harvest these body parts for research, and some of the babies were dissected while they were still alive.

This gruesome practice was recently documented in a California state and federal court during the trial involving Sandra Merritt and David Daleiden, the two undercover journalists that revealed this ongoing horror in video-taped public conversations.

An investigation by *ABC News 20/20* in 2000, also shown in court, revealed that the same gruesome harvesting of baby body parts has been ongoing for at least two decades. Yet, not a single abortionist has been charged with a crime. It is time for a change.

- To silence Sandra Merritt and David Daleiden, the California Attorney General and Planned Parenthood filed charges in state court and a multimillion-dollar lawsuit in federal court. Testimony under oath confirmed crucial details exposed in those videos.
- Planned Parenthood was supplying hearts, livers, lungs, kidneys, brains, and more for sale to organ procurement companies that sold the baby body parts for enormous profit. Some of the babies were alive when their body parts were removed.
- Medical staff were recorded publicly describing cutting open the face of a 25-week-old newborn baby to harvest his brain while his heart was still beating. Keep in mind that this is nearly a month after the age of viability outside the womb!
- An abortionist who killed tens of thousands of babies said, "There's no question in my mind that at least some of these fetuses were live births." Under oath, it was confirmed that they were altering their abortion procedure to cause "tumultuous labor" at great pain to the mothers. The longer labor time caused unnecessary risk to the mothers, all without their consent.
- In addition, the heads of aborted babies were being scalped and their skin grafted onto "humanized" mice whose immune system was suppressed to accept the graft so that researchers could test for baldness.
- The California Attorney General's office alluded to infanticide being acceptable, perhaps even legal, in the state, as long as the child was earmarked for an abortion while it was in the womb. This is paired with that office's steady refusal to prosecute even a single abortionist in the four years since infanticide was exposed.

This needs to stop! The U.S. Congress has two related bills to close a loophole in the current law. Both have stalled due to a Democrat-led House and a Democrat-led filibuster in the Senate. There are no punishments for medical staff who neglect, abuse, dissect alive, or outright murder a living newborn after a failed abortion. There are hundreds of known adult abortion survivors living among us, and who knows how many more. Don't these newborn babies deserve the chance to be more than a science experiment? There are 277 legislators in D.C who are fighting this legislation. We are 20 legislators short of what is needed to pass this law which is critical—because the murder of a newborn baby should always be illegal.

Dysfunction associated with the aging process positions aging as a leading culprit for development of devastating diseases and mounting healthcare costs. Many age-associated conditions for which aging increases risk are neurological disorders with no effective treatments, including Alzheimer's disease. As the proportion of aged individuals continues to rise in the coming decades, aging-related costs are expected to increase dramatically. Diverse approaches have emerged to meet the clinical need to treat aging and its associated conditions, including those aimed at increasing longevity, slowing the aging process itself, and improving healthspan. An emerging approach takes advantage of molecules circulating in the blood to limit or reverse aspects of aging in various organs throughout the body. Efforts are underway to translate these findings into novel therapeutics that harness the activity of youth-associated molecules present within blood. Here we discuss the current state of blood-based approaches in this arena. Despite the apparent ease with which blood products might conceivably be applied as treatment paradigms, we propose that challenges nonetheless exist, which may be overcome with mechanistic studies that identify common pathways for targeted therapeutics.

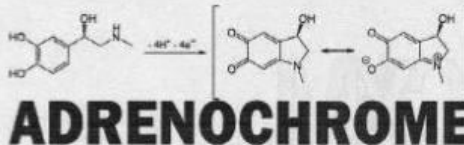

A liver can cost up to \$ 350. In a video shot "undercover" inside the Planned Parenthood by the pro life Center for Medical Progress, **the price list of the Da Vinci Biosciences** company, a fetal tissue brokerage firm , also appears : **\$ 750 for the brain of the fetus, 500 for the lymphatic glands, 350 for a kidney.**

The market is profitable and **Dr. Jörg C. Gerlach, an experimental surgeon at the University of Pittsburgh, has developed a dedicated technique to harvest uncontaminated livers from live births following late abortion** .

Gerlach's so-called "**protocol**" for liver harvesting is used for experimental stem cell transplants according to the "Current Good Manufacturing Practice", or cGMP, guidelines developed by the US Food and Drug Administration (FDA), another branch of the HHS (United States Department of Health and Human Services). According to medical publications, vivisection procedures generally take place at the University of Pittsburgh and are funded by the NIH (National Health Institute) with a whopping \$ 2 million since 2011.

In the middle of the book of Joshua is a forgotten story of five women who practiced Civil Disobedience. I am speaking of Mahlah, Noa, Hoglah, Michah and Tirzah. None of them were married and none wished to have to marry simply to receive their inheritance from their father. These unmarried daughters “went to Eleazar, the priest and the leaders and said, “The Lord commanded Moses to give us an inheritance among our brothers.” So, Joshua gave them an inheritance, along with the brothers of their father, according to the Lord’s command.” They laid out their case: “Our father died in the desert. Why should our father’s name disappear from his clan because he has no sons?” These five women had the audacity to claim their birthright without apology and they got it.

A modern day application can be seen in social security owed a widow whose husband handled all financial affairs. Far too often she has to argue with the SS department to receive money paid in by both her and her husband over the course of their marriage. She has to wrangle with them like at war. This message is for her: NAG until you get through to someone in authority and demand what is owed to you, so you do not have to resort to eating cat food or choosing between your medications and paying outstanding bills. Our current societal model penalizes women who stay home and raise a family, but the joint funds paid in via taxes to SS is their birthright and nothing should hinder them from getting it when their husband dies.

If Sisera sounds familiar, it is because he is the same one Jael killed with her tent peg. Barak's reluctance to lead stands in stark contrast to Deborah and Jael's swift action to save their people from being attacked, with the female married women killed and the younger women raped as trophies of war.

Application for Modern Day Activism: Today's relevance is blatantly obvious as we enter 2024 and men are reluctant to focus on child sex trafficking and are glued to the stock market instead. What will you eat when your money is worthless, men? Will your wife still love you when you cared not one whit about protecting the family home and learning the art of self-defense? Far

too many men have become soft and doughy around the middle. It is a shame that not all young men have to serve in the army, gird their loins, and do battle at least once in their life. It is more than evident they have chosen to dress like women and keep their hands soft, instead of accepting their God-given role.

There is no doubt in my mind that Deborah would have called out all transgenders too, as was done in Deuteronomy 22:5: “A woman must not wear men’s clothing, nor a man wear women’s clothing, for the Lord your God detests anyone who does that.” Weak men who refuse to behave like men deserve to be whiplashed by a woman’s tongue, as Deborah did. Each gender has a part to play in protecting society: women give birth to families, make the clothes the family wears and men work the garden, tend the animals and protect the cave from intruders. That is the way it has always been and, guess what, that is the way God intended for it to be.

To prevent men from becoming weak, women must demand more and better of them. Women should not allow crude movies with hyper-sexualized female actors to come into their home; *your home is your castle too*. Throw the bilge out. Women should not read books of a prurient nature, such as romance novels. Throw the bilge out. It becomes painfully clear why no minister ever mentions Deborah, Delilah, Jael or Judith since their stories serve as a constant embarrassment to weak male leaders. The Protestant Bible has gone so far as to excommunicate the book of Judith so they never have to face their shame. Nevertheless, the stories are too strikingly similar in tone and outcome to be a mere coincidence. Powerful men are brought low. They lose their focus, their eyesight, their head at the hands of a woman. Let that be a warning to all weak men!

Application for Modern Day Activism: The consequences for committing an act of pedophilia, rape, incest should be the death penalty and more women need to demand that this be the case. For too long the Supreme Court has held that the death penalty for these crimes is “disproportionate” and violates the 8th Amendment. The Supreme Court has protected offenders and not victims. This is something women must rise up and change. A child’s rights should not change from state to state; the legislation put in effect in TN should be nationwide. Any person

convicted of raping a child should be put to death. Rape is a heinous crime that severely impacts the victim's life, shattering them physically, mentally, and socially. There should be the harshest possible punishment for such criminals to send a strong message that such acts will not be tolerated under any circumstances.

Jesus said that the Father has concern for all of His “little ones” (Matthew 18:1-14). In that passage Jesus says, “But whoso shall offend one of these little ones which believe in me, it were better for him that a millstone were hanged about his neck, and that he were drowned in the depth of the sea” (Matthew 18:6, KJV). The word offend in the Greek means “to cause one to stumble, to put a stumbling block or impediment in the way, upon which another may trip and fall, to entice to sin, or to cause a person to begin to distrust and desert one whom he ought to trust and obey.”

Pedophiles are clearly “without natural affection” (Romans 1:31; 2 Timothy 3:2). The phrase “without natural affection” is translated from one Greek word, which means “inhuman, unloving, and unsociable.” One without natural affection acts in ways that defy the social norm. This would certainly describe a pedophile.

The fact that the Catholic church has not condemned pedophile priests and our current laws are too lax does not in any way change the fact that GOD condemns those who rape a child. There are no MAPS, minor-attracted people; the term is an apostasy. There are only those who have natural affection between an adult man and an adult woman, and those that do not. Here again, we are to follow God's laws, not the laws of men, who have done much over the past centuries to protect their own and leave women and children defenseless. Hindu, Muslim and Buddhist nations are taking the lead: India, Pakistan, Saudi Arabia, Iran, United Arab Emirates, China put to death their pedophiles and rapists. I believe that victims deserve to know the perpetrator will not get out of prison to harm them in the future; 30% of child sex abuse victims are

abused by family members and 90% of victims know their abuser. Society at large deserves to know it has permanently removed a predator who behaves like an animal and is unnatural. Capital punishment is the appropriate outcome. The tribe of Benjamin was cut off for the sin of sexual immorality. Women should not tolerate the ruling on child rape in the court case *Kennedy v. Louisiana* (2008). The Court emphasized the “hurt and horror inflicted” by perpetrators of child rape and the “years of long anguish” endured by the victim, but it said the death penalty would be “unusual for this crime.” I refuse to accept that decision, and I hope you don’t as well. Oklahoma, South Carolina, Montana, Louisiana, and Florida are the only states thus far to allow the death penalty to protect children. We must enlarge that to all 50 states, our federal district of Washington, DC and all 16 US territories: American Samoa, Guam, Northern Mariana Islands, Puerto Rico, United States Virgin Islands, Minor Outlying Islands, Bajo Nuevo Bank, Baker Island, Howland Island, Jarvis Island, Johnston Atoll, Kingman Reef, Midway Islands, Navassa Island, Palmyra Atoll, Serranilla Bank, Wake Island.

Perhaps there is a reason so many aides are raped on the hill in DC, since DC residents fulfill all the obligation of US citizen but are denied representation. Gov. DeSantis signed House Bill 1297 into law Monday, making sexual battery cases committed against children under 12 punishable by death.

4. South Carolina Governor Mark Sanford and Oklahoma Governor Brad Henry have signed into law legislation that allows prosecutors to seek the death penalty for repeat child molesters. The new South Carolina law allows a death sentence if the accused has been twice convicted of raping a child younger than 11-years-old. David treated Michael who had loved him in his youth like chattel and his response is telling, “I will lower myself even further!” This he surely did in marrying the wife of a soldier, then sending him to the front lines of war so he would be killed. That is the story of Bathsheba who gave birth to Solomon who built a temple that honored other Gods than YHVH.

Application for Modern Day Activism: Let me tell you a story that relates. I once befriended a woman who would never correct her husband; he drove his family into debt with his many get-rich business schemes; he nearly lost the family home; he was entirely unable to pay his bills. Still, she refused to speak up and she said she was doing so “because the Bible tells her to be passive and let the man lead.” I called her out one day and told her that simply was not true; I showed her Bible passages using my first book sent home through her daughter. Even having gone to a Bible college, she refused to apply the lessons evident in scripture that told her to end his folly. It was

evident to all around her that she was married to a nabal and she should have dealt with him as Abigail did. Such passivity is not godly and it should not be confused with being feminine either. Women are not to remain silent in the face of imminent disaster. Rebekah did not allow the less faithful son to prevail; Puah and Shiprah did not obey genocide orders from a king; the daughters of Zelophad did not allow their inheritance to be taken from them; Deborah did not let weak men forget their lack of courage; Delilah, Jael and Judith did not allow their villages to be savagely destroyed; and Michael and Abigail did not tolerate foolish behavior from “nabals.”

Let us tackle the passage most often used by men to justify the submission of women to men. Behold, Ephesians 5: 23-23:

“Wives, submit yourselves to your own husbands as you do to the Lord. For the husband is the head of the wife as Christ is the head of the church, his body, of which he is the Savior. Now as the church submits to Christ, so also wives should submit to their husbands in everything.”

The only problem with this passage is that it is *not read in its entirety*. Men like to stop after the first part. But, there is more, much more...and it involves a man’s responsibilities, if he wishes the wife to do the above:

“Husbands, love your wives, just as Christ loved the church and gave himself up for her to make her holy, cleansing her by the washing with water through the word, and to present her to himself as a radiant church, without stain or wrinkle or any other blemish, but holy and blameless.”

A man is not to be a pampered mommy's boy; *he is to leave his mother and be united to his wife*, just as she leaves her father to allow her husband to lead "in a holy and blameless manner." The submission goes both ways and forget not Proverbs 22:3: "The prudent sees danger and hides himself/herself, but the simple go on and suffer for it."

There is nothing in the Bible that says women are to sit idly by as men rule the world and drive it into economic debt and destroy the planet's resources out of greed. There is nothing in the Bible that says women are to tolerate the making of gain-of-function, chimeric bioweapons that are a runaway train that cannot be stopped. There is nothing in the Bible that says women are to sit idly by and allow men to create space war programs and goad other nations into worldwide star wars battles. There is nothing in the Bible that says women should allow men to create a Hadron collider to duplicate the Big Bang and blow up the world in a grand "reset" to start over. There is nothing in the Bible that says women are to tolerate geo-engineering which has created the most recent tsunamis, earthquakes, tornados and hurricanes. There is nothing in the Bible that says women are to tolerate and be passive about men's attempt to have themselves, and men made into women with drugs and surgery, rule the world and steal a woman's role as mother.

There is much in the Bible about not losing your soul to those who seek to control it. Not even your husband owns your soul, nor your government, nor your church leaders, nor your current president. Beware of dangerous AI to come that wants to steal your God-given right to freedom of movement, freedom to worship God, freedom to use your God-given talents, freedom to speak and sing his praises, and your role bring a new child into the world.

Prophetess Huldah

Josiah was only eight years old when he became king. In his 18th year, he sent his secretary, Stephan, to the temple of the Lord to oversee work on construction. Hilkiah, the high priest, gave to Stephan a forgotten book, The Book of Law to give to him. Only Huldah had the qualifications to interpret it. She said to him:

“This is what the Lord, God of Israel says: “Tell the men who sent you to me: I am going to bring disaster on this place and its people because they have forsaken me and burned incense to other gods and provoked me to anger by all of the idols their hands have made.”

What had the men done? They had sacrificed babies in the fire, tolerated male prostitutes, and put up shrines to other gods: Molech, Asherah and Moab. Application for Modern Day Activism: From Huldah women learn to be straight shooters. There is nothing in her words that is watered down so the men can save face. Vashti

The story of the Queen of Persia named Vashti begins in Esther 1:1. King Belshazzar's surviving heir after his assassination was his granddaughter, Vashti, according to the Book of Daniel. This also makes her the great granddaughter of King Nebudchanezzar. Darius the Mede predicted the assassination of King Belshazzar in Daniel 5 and planned to cement his authority, by marrying Vashti off to a lowly soldier in his ranks named Ahasuerus; Xerxes, in Greek. This is a critical point to the story of Vashti and so very rarely mentioned. Esther

This story is much like that of Delilah, Jael and Judith in that Esther had to lull an irrational king into a relaxed mood before hitting him with the truth that his appointment of Haman was a rash and irresponsible move. Tricking men into listening to women seems to be a strong theme in the Bible; and, it is considered a godly thing to do.

Application for Modern Day Activism: First of all, expect men in power to get themselves tangled up like a pretzel over who has greater power and seniority. It comes with the territory with being a man, apparently. Expect to have to bail them out, ladies, when they cannot find their way out of the mess they have created, to save society, women and children from destruction. Too many have not learned to kill their ego.

Secondly, do not accept the “it can’t be done” mindset of weaker women. There is a way around every mountain that stands in your way; you just have to look for it or create the path with a shovel. - September 1, 2021 – Initial incentive payment

How you can qualify for a bonus

The Women of the New Testament

The women who surrounded Jesus and began churches in their homes rescued babies set out for the sin of being born female instead of male. They stood at the foot of the cross when he was crucified and did not abandon him; they were the first to witness his resurrection. These women taught and they baptized, Tertullian had to admit. The women of the New Testament are like a vast army and were said to be as courageous as lionesses. We have Mary, mother to Jesus, Mary Magdalene his number one student, Mary Salome, Mary of Clopas, Beatrice, the Women of Acts, the Women of Romans, the Women of Corinthians, the Women of Phillipians, the Women of Colossians, the Women of 1st Timothy and 2nd Timothy, the Women of Titus, the Wife of Peter and the Wife of Paul [bless her soul, she must have been a saint]. I think it is Jesus' treatment of women that got him killed, for he spoke to women, he noticed women at work, he felt they were equal to men in both energy and the desire for soul work. Unlike other rabbis who would not talk to a woman for fear of lustful thoughts, Jesus sought women out who needed to hear his message; he allowed a woman niddah with menses to be healed by just the touch of his hem. We know that he told his true identity to a woman with multiple husbands; he knew who she was; he told her about her life, and then he told her about his. He told Martha that Mary was doing the "better work" learning the gospel than fretting over the preparation of one night's meal. How the other men and rabbis must have

hated him for giving women so much credit and time! How the other men and rabbis must have hated the fact that he told women they had a soul, just like men, and an identity outside of “the wife of”! How the other men and rabbis must have hated that he would not stone the female caught in adultery without asking where the man was too! Jesus broke with men who wanted a younger wife to replace an older one; how that must have rankled them. Jesus not only challenged rabbis, he challenged the traditional order and male superiority.

The Gospel of Thomas shows us that even Peter was jealous of Mary Magdalene’s close relationship with Jesus. She was privy to teachings beyond that of the other disciples because she was not concerned with which seat would be hers in heaven; she was an exceptional student. Peter declared after Jesus death that he was the new leader and to Mary Magdalene he said: “Who is this woman that we should listen to her?” I would say she was the chosen one of our Lord; that is why you should have listened, Peter.

Jesus injunction to be “born again” must have rankled the apostles and other rabbis, for, being men, they could not give birth, and the role put them in the odd position of relying upon a woman to go to heaven. Jesus himself did not arrive on the planet as a full grown man; he was born like every other child, from a woman’s womb, in order to be fully human and understand our foibles and strengths. Even wise men like Nicodemus could not figure out what Jesus was saying when he said those words: “you must be born again.” Why did Jesus use a term solely in the realm of the feminine, utterly unknowable by men? I think it was part of his plan to make men humble, and that it did. There is only one thing on the planet men cannot do and that is bring forth life, and for some reason that rankles them enough to want to be transgendered and pretend that they can do it too, with an AI womb or a woman masquerading as a man.

Jesus also changed the “priesthood of all believers” and mandated removal of the tip of a foreskin to a baptism that all women could participate in. I imagine that really set their teeth on edge, just as altering the Bible from Latin to English so it would be accessible to all, must have irritated priests who felt they had a corner on worship that laymen could not access. Everything changed when the curtain was ripped and God was placed in our hearts, so we would never have to go wandering around looking for a specific place to know him. Stop seeking after other guru’s.

Application for Modern Day Activism: First of all, she should be grateful that she is an integral part of God's plan. She was not an afterthought and she was not designed to be chattel. Far from being weak and passive, the Old Testament women were equal to men, sharing the Good News with any they encountered; in fact, if you consider what these women did, you will see they took on enormous responsibility to feed the masses, heal those sick, protect widows left bereft of survivors, and even did battle in the Colosseum.

Far from being pacifists, the final standoff between Romans and the followers of Christ was at Masada, a mountaintop fortress in Israel. Nine-hundred and sixty-seven men, women and children stood off a sea of Romans, trying to evade capture and crucifixion. That terrible event occurred in 66-74 AD. The ideas Jesus shared will never die. They cannot be killed. They refuse to die because they are part of us, just as our hand is attached to our body.

Civil Disobedience for Christian Women: A Checklist for You to Use

1. Support Pro-life women's shelters with donations of money, cribs, handmade clothing, diapers, etc. Find out what is needed and give it.

2. Actively protest pro-choice abortion centers in your area. Show these women films of what a baby looks like at 10 weeks. Some of them yet think the fetus is just a clump of cells instead of a wee baby with fully formed eyes, hands, feet and head.

3. Remove from your home all filth, all R rated movies and P-G 13 movies that normalize violence, the LGBTQ agenda and lascivious acts. Flip the switch when commercials come on that show previews of the same. Your children do not need to see this filth; once it is in their brain it cannot be removed. You must be the screener who keeps the filth out of your home. Take it out like the garbage it is.

4. Remove music that is not uplifting and positive. Remove rap with lyrics about rape and cop killers, death and suicide. Crack the CD's and toss them in the trash and do not allow friends and family to send or buy any more of them. You can unload the dishwasher, reload the clothes washer, vacuum and make the beds in one hour flat, if you set your mind to it. The women of the New Testament were not lazy; they ran businesses in addition to taking care of their own families, along with helping the needy. They were busy dawn to dusk, not fussing with their hair and nails.

7. Make your own clothes so you are not dependent upon stores that sell items in hideous Pantone colors in sizes that start with zero, picked by gay men. That's the real reason clothes off the rack

don't fit women. They were not made by women for women. Why purchase something that doesn't fit and have to alter it, when you can make it perfectly from scratch in just a few hours' time? The hem will fall where it should be, just above the knee, and the fit will be accurate.

8. Learn to crochet and knit. Make comforters and blankets for your family and others. Teach your daughters to do the same. Boys should also learn basic sewing skills, like how to sew on a button, take in a seam, take out a seam, or patch a hole in their britches. Plenty of men are tailors and they had to start somewhere.

9. The basics of cooking should be known by everyone in the house, so when mother gets sick, the whole world doesn't fall apart. Rather than shoo them from the kitchen, make each child watch and learn how to do the things you do to prepare meals. Too many young brides are utterly clueless how to prepare a turkey, and why is that? They were never taught by their mothers how to do it. Your sons need to learn how to cook too; there are plenty of chefs who started learning in their mother's kitchen. From measuring to stirring and taking it out of the oven; they should observe every step, so they will be able to duplicate it in the future or themselves or their families.

10. If there is time for men to study the Bible, there is time in the day for women to do the same. Soul work is not gender specific. His edification reading in the evening is not more important than yours. Make sure if you are married that you divvy up the remaining household chores from 6-10 pm, so there is time for you to read as well. The old adage, "Women's work is never done" is a bad one. A broom does not behave differently in a man's hands than a woman's, nor does the laundry machine, or the dishwasher. Beds should be made by those that sleep in them; teach your children to make their own with crisp corners.

11. There is nothing you can do to your body that will make you feel better about yourself, if your mind is following a negative train of thought. So many women think "the problem" is that they are ten pounds overweight, or they too many wrinkles, or their hair is graying. No, the problem is you are obsessing over getting older and you are trying to compete with your daughters and women who are half your age in the workplace. Stop it. There is nothing in the Bible that tells women they have to compete with anyone to be loved. Stop obsessing over aging. Learn to love the skin you are in. Men don't have it easier than women, nor women easier than men. Changing your gender

will not bring the relief you seek. The problem is in your thinking not with your body. Be thankful to be alive and to be a woman.

12. Adam and Eve began life in a garden. Begin one. Start tilling a small patch and soon it will enlarge over the years, as you see the fruit of the vine in your own backyard. Tomatoes, cucumbers, watermelons, squash, dill, oregano, cilantro and basil—these are easy things to grow for anyone at any age. Make your backyard a Garden of Eden, a place of respite for when you are tired at the end of the day. Let your home become the most beautiful one on the block, not out of vanity, but out of pride in ownership. Surprise your landlord, if you are a renter; care for it so well neighbors assume you own it.

13. Christians should not be sloppy in appearance, nor should women dress in the hyper-sexualized manner of the general public who buy into the need for “sex appeal.” Have sexy lingerie, but keep it for times when you and your husband are alone. Don’t wear a black bra under a white shirt as hedonists do, nor exercise pants that show every bulge. Christians don’t have tattoos because their body is their temple; they don’t deface it with tribal markings. Their confidence comes from knowing they are made in God’s image and that is enough to keep them running on all four cylinders until the day they die. They don’t need to stand out in a shocking manner; they are already a “peculiar people” based on their faith alone.

14. Teach your daughters not to use “sex appeal” to get a job, or she might get raped while getting the coffee. If she dresses like a prostitute, she will be taken for one. Make certain your children leave the house with their blue jeans around their waist not under their butt, with no cleavage hanging out, no bra straps showing under the top, and no distracting clinging to anything on their bodies. Let their focus be on school and nothing else and let them help others to do the same.

15. Political involvement is the realm of women, not just men. Women are the only ones who are going to stand up and protect women and children because we are the ones who bear them. We have to protect them from wicked people, so start a neighborhood watch, and keep an eye on who enters and leaves your street. My office desk faces the street and when I see a car I don’t recognize, I pick up my camera situated right on my desk. When you approach a window with a camera, it’s amazing how fast a loitering car will speed away.

- a. Fight against child trafficking in your city. Know how many are disappearing and the locale.
- b. Constantly nag about veterans and widows who do not have enough food to survive. Tax exempt churches should not be turning anyone in need away, mega-churches in particular. A food pantry and clothing closet need to remain open 24-7; people don't eat only on a Sunday. Older women may not know how to fight for their spouses SS check; teach them how to do it.
- c. Help a victim report a rape. Use the day after pill, if you are raped. There is nothing in the Bible that says you have to bear the child of violence. Take the man to court and be like Susanna, recalling all of the details you know he has overlooked. Be persistent if the man is wealthy; don't let him buy his way out with a "sweetheart deal" or he will be a repeat offender.
- d. Approach misogynist men as Vashti did. Refuse to come. Refuse to obey. Refuse to debase yourself. Have locks on your doors and alarms that work regardless of electricity or the internet, so nobody can enter when you are bathing or sleeping.
- e. Follow the money and shine a bright spotlight on wasteful spending. Read bills that come out of Congress and look at the 2024 Congressional Pig Book: <https://www.cagw.org/reporting/pig-book> Fight to get pork removed.
- f. Be involved in school affairs, from the food served to classroom instruction. These are your children; they do not belong to the government. Don't be the last to know about the curriculum; get together with other parents and ask to see the books used for each grade level. You paid for them with your tax dollars; why should you be able to see them? What's the big secret? Don't tolerate drag queen story telling hour or sex education taught in kindergarten. Be like the parents who show up at board meetings and read aloud the prurient passages the teachers don't want you to see, until it's too late. Be a thorn in the side of the Department of Education.
- g. Remember your birthright. Don't be like Esau who gave his up for a bowl of lentils. Be like the daughters of Zelophad instead, who demanded their fair share. Be a squeaky wheel.
- h. Did Puah and Shiprah comply with a king's orders to commit genocide? No they did not. Then stop nurses and doctors who are pushing risky vaccines to increase their own personal profit and that of their hospital. Do not comply with "mandates." You are not a guinea pig. Do not
